EU Recovery Instrument – A step towards a sustainable economic recovery

UPEI, as the voice of Europe's independent fuel suppliers, strongly welcomes the European Commission's proposal for an updated EU budget, which seeks to address the actions needed to drive Europe's recovery from the economic downturn caused by the COVID-19 crisis supporting the EU's transition towards a sustainable, digital and resilient economy. UPEI equally supports the proposed the new EU Recovery Instrument, also called Next Generation EU, which will guide and build a more sustainable, resilient and fairer Europe, all the while supporting companies severely affected by the COVID-19 spread via the proposed Solvency Support Instrument and similar measures.

"Independent fuel suppliers have experienced a substantial impact on their business activities, as COVID-19 outbreak hit harshly fuels demand across Europe", said Brian Worrall, UPEI President. "The European industry, and the transport sector in particular, needs to undergo exceptional measures in order to recover. This unprecedented challenge represents a pivotal opportunity to reshape the energy sector as we know it."

To achieve this goal, an ambitious and stable policy framework is crucial. UPEI members are fully committed to provide flexible, affordable, and clean energy to consumers in order to meet Europe's short- and long-term climate objectives.

We believe that the transition to climate neutrality will require a combination of technologies, as there is no silver bullet to climate change. Supporting all types of technologies that can have an impact on decarbonisation is the only affordable way to effectively reach carbon neutrality, both in the transport and heating sectors.

The European Recovery Instrument will play an essential role in shaping the policy framework for the sector, hence we stress the need to set out favourable investments in low-carbon technologies, such as hydrogen, advanced biofuels, biogases, e-fuels and recycled carbon fuels. UPEI further calls on the Commission to provide clear and comprehensive pathways setting out how it will support these areas in the upcoming Sector Integration, Hydrogen, and Smart and Sustainable Mobility Strategies. Moreover, the Recovery Instrument should also support investments into repurposing existing fuel distribution infrastructure to meet the demands of a greener Europe.

UPEI, being the voice of Europe's independent fuel suppliers, is in a unique position to offer perspectives to the EU long-term strategy and contribute to this challenge. As we represent approximately one third of Europe's import and wholesale/retail distribution of energy, our members will be a critical element in the supply chain to bring low carbon solutions to consumers, providing a full coverage of the European territory.
