Joint position on the applicability of synthetic fuels to heating in the Renewable Energy Directive (RED II)

Brussels, 16 March 2018

The undersigned associations, ECFD, Eurofuel, FuelsEurope and UPEI, representing the supply chain of liquid fuel products for heating would like to raise EU policy-makers' attention to specific elements in the future Renewable Energy Directive (RED II), which may impede the development of innovative liquid fuels which reduce greenhouse gas emissions in the heating sector.

With regards to Article 2 of the European Commission's proposal currently being negotiated in trilogue, a definition of "renewable liquid and gaseous transport fuels of non-biological origin" is included, which de facto excludes the use of similar renewable liquid and gaseous fuels of non-biological origin for non-transportation purposes¹.

The European heating sector is currently facing climate policy challenges similar to the transport sector. It is constantly striving to improve efficiency and emissions both in the technology and energy used. Ongoing innovation to develop alternative liquid fuels is an important part of these efforts as a means to contribute to the carbon emission reduction objectives set by the European Union for 2030 and towards 2050. An open legislative framework that recognises and promotes such possibilities is needed.

The properties and merits of using renewable fuels of non-biological origin in the field of residential heating are being investigated through studies and several pilot projects² and our industry considers that these synthetic or "e-fuels" made from renewable electricity and different sources of CO_2 are likely to play an increasingly important role to supply liquid fuels for heating in a medium to longer term³. They could be part of the solution to a decreasing carbon footprint in Europe's heating mix, as an ideal solution for the progressive reduction of fossil fuel content in the 20 million heating systems powered by oil across Europe.

We therefore believe that the RED II may play here an important role in stimulating further research and investment in these e-fuels and their applicability to the residential heating sector, by extending the definition to heating uses and ensuring that such fuels are properly accounted for in the provisions relating to renewables in heating and cooling, as per our proposal in annex.

Annex: Possible wording to address the concerns highlighted in this paper

Proposal for a directive

Article 2 – Paragraph 2 – point s

Text proposed by the Commission

(s)'renewable liquid and gaseous *transport* fuels of non-biological origin' means liquid or gaseous fuels other than biofuels whose energy content comes from renewable energy sources other than biomass, *and which are used in transport*;

Amendment

(s)'renewable liquid and gaseous fuels of nonbiological origin' means liquid or gaseous fuels other than biofuels whose energy content comes from renewable energy sources other than biomass;
